Petition Number 2018-48-JPZ-0097, proposes to amend the Calification Map of the Autonomous Municipality of San Lorenzo with cadaster number 278-007-109-25 from a District I-L to C-I, which is located on the PR-916, State Road Intersection PR-183, Cerro Gordo Ward in the Municipality of San Lorenzo.
