Field Inspections for other divisions (Uses, Environmental Compliance, Buildability, etc.) are rare and usually assigned by the Manager of the Division.

DDEC oversees OGPe's compliance with procedures and public policy.
С	34	Is the project funded 100% by federal funds for the duration of the contract?	2/27/2019	No. Federal funds vary per year of the program. Federal share is 75% for years 1 to 3, 50% for year 4, 25% for year 5 and 10% for year 6.
