The University of Puerto Rico at Carolina is issuing this invitation for Bid (IFB) to request sealed bids from qualified individuals and/or entities for:

SECOND TEMPORARY ROOF REPAIR OF THE UNIVERSITY OF PUERTO RICO AT UNIVERSITY OF PUERTO RICO AT CAROLINA

On September 20th, 2017, Hurricane Maria hit Puerto Rico causing catastrophic island wide damages. In response to this major disaster, the Governor of Puerto Rico issued the Executive Order Number OE-2017-047, declaring a state of emergency in Puerto Rico. Additionally, on September 21, 2017, the President of the United States of America issued a Major Disaster Declaration for Puerto Rico, ordering federal assistance to supplement the Government of Puerto Rico's (GPR'S) recovery efforts and authorizing federal funding for emergency works in all of our seventy-eight (78) municipalities, in order to begin to recover from the effects of this catastrophic disaster.

This Project aims for the installation of a temporary roof waterproofing system providing a 5-year warranty period on the buildings in the area of University of Puerto Rico at Carolina. The scope consists of roof preparation including but not limited to removal and disposal of debris, removal and disposal of urethane, roof wash, repair of "blisters", and application of asphalt emulsion and installation of membrane, as specified. Responses to this IFB should be prepared in accordance with the instructions provided in the IFB package. At the same time, it shall comply with the Executive Order 2018-033, issued on July 30, 2018. 
Bidders shall submit their proposals on or before 10:00 am of July 30, 2020, at the Physical Resources Office, building Physical Resources. All bids received will be publicly opened and only bidders name and bid amounts will be read aloud. The IFB process is designed to promote fair and open competition while seeking cost competitive option. All bidders shall be qualified to obtain and submit a Bid Guarantee equivalent to five percent (5%) of the bid, valid for two hundred thirty (230) days in the form of certified check, bank draft, US Government Bond at par value, or bond from an approved insurance company that appears in the Federal Register (Treasury Listed) Circular S70 and authorized to do business with the government of Puerto Rico.

This solicitation complies with applicable local and federal laws and regulations, including 2 C.F.R. Part 200 – Uniform Administrative Requirements, cost Principles, and Audit Requirements for Federal Awards, among others. The Bids will be held in confidence and will not be released for public review until the final awards is completed.

In accordance with 2 CFR-Part 200, the Bidding Board will award the project to the responsible bidder whose bid, conforming with all material terms and conditions of the invitation of bids, is the lower in price.
