## Resumen Ejecutivo

La Junta de Planificación de Puerto Rico (JP) es la entidad oficial a cargo de toda la información económica y social principal del Gobierno de Puerto Rico. Los datos estadísticos generados sirven de referencia y de guía en la toma de decisiones y el diseño de la política pública dirigida a lograr un desarrollo económico, social y físico de la Isla.

En nuestro continuo esfuerzo por modernizar el nivel de nuestras estadísticas de acuerdo a los modelos vigentes, hemos iniciado el proceso de transición hacia el Sistema de Cuentas Nacionales del 2008 (SCN 2008), de acuerdo con los criterios metodológicos recomendados por los organismos pertinentes. Esto incluye la Organización de Naciones Unidas, el Fondo Monetario Internacional y el Negociado de Análisis Económico de los Estados Unidos. Para la actualización de las Cuentas Nacionales hacia un nivel de SCN 2008, hemos escogido como punto de partida las transacciones entre Puerto Rico y el resto del mundo. La Balanza de Pagos y Posición de Inversión Internacional de Puerto Rico 2018 incorpora lo establecido en la sexta edición del Manual de Balanza de Pagos y Posición de Inversión Internacional (MBP6), el cual es cónsono y se actualizó de forma paralela con el SCN 2008. Además, incluimos, por primera vez desde la década de los ochenta, los estimados de inversión directa en las cifras de montantes y movimientos de capital entre Puerto Rico y el exterior.

Estamos conscientes de los retos que conlleva un proceso de revisión de un sistema tan complejo como el de las Cuentas Nacionales. Por ende, nos reiteramos en la mejor disposición de mantener una verdadera retroalimentación entre la JP y nuestros usuarios de información, para el beneficio de los grados de fidelidad y confianza de la información que se presente en nuestras publicaciones. Agradecemos a las entidades públicas y privadas que proveyeron los datos utilizados para preparar esta publicación.

## **Executive Summary**

The Puerto Rico Planning Board (PRPB) is the official entity in charge of all the principal economic and social information of the Government of Puerto Rico. The statistical data generated serves as a reference and guidance in the decision-making and design of public policy aimed at achieving the Island's economic, social and physical development.

In our continuous effort to modernize the level of our statistics according to the current models, we have begun the transition process towards the System of National Accounts of 2008 (SNA 2008), in accordance with the methodological criteria recommended by the pertinent organizations. This includes the United Nations Organization, the International Monetary Fund and the Bureau of Economic Analysis of the United States. For the update of the National Accounts towards an SNA 2008 level, we have chosen as a starting point the transactions between Puerto Rico and the rest of the world. Puerto Rico's Balance of Payments and International Investment Position 2018 incorporates the provisions established at the sixth edition of the Balance of Payments and International Investment Position Manual (BPM6), which is in harmony and updated in parallel with SNA 2008. In addition, we include, for the first time since the 1980s, the direct investment estimates in the figures for value and capital movements between Puerto Rico and abroad.

We are aware of the challenges involved in a process of reviewing a system as complex as the National Accounts. Therefore, we reiterate our willingness to maintain a real feedback between the PRPB and our users of information, for the benefit of the fidelity and confidence levels of the information presented in our publications. We thank the public and private entities that provided the data used to prepare this publication.

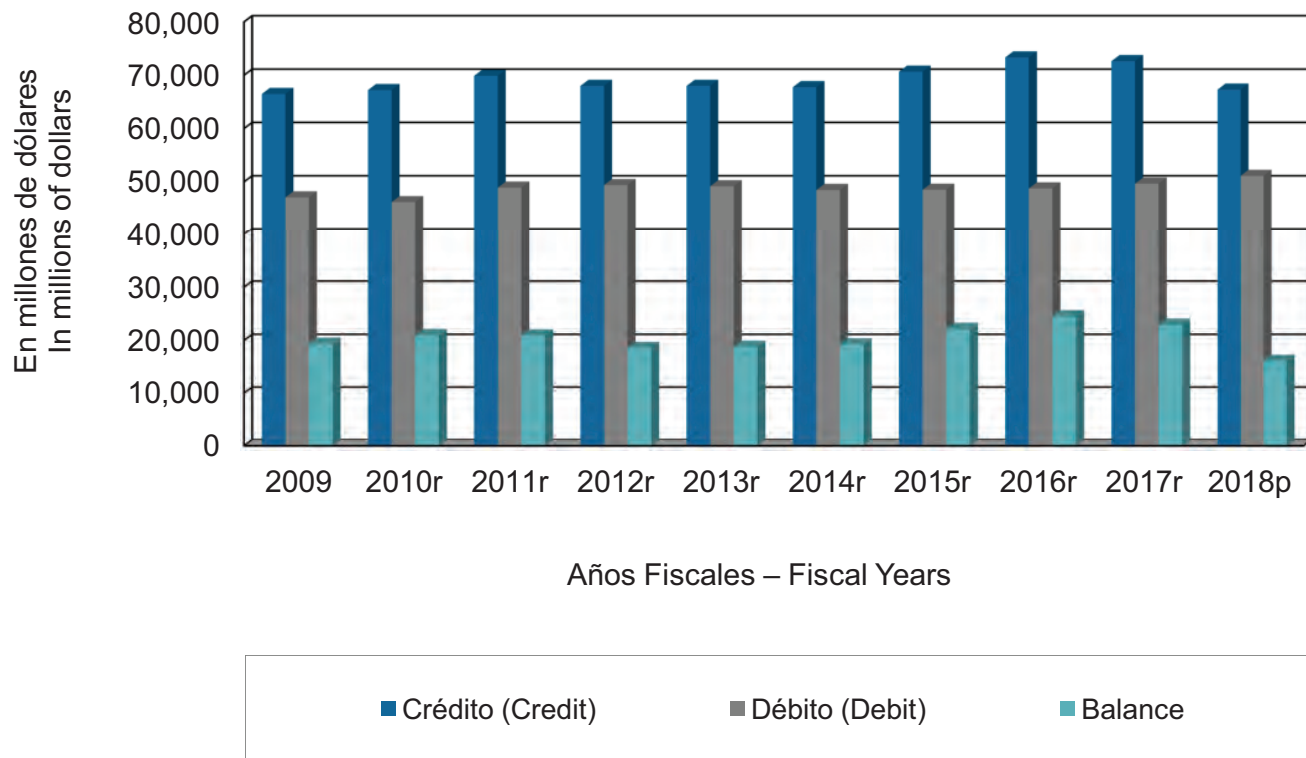

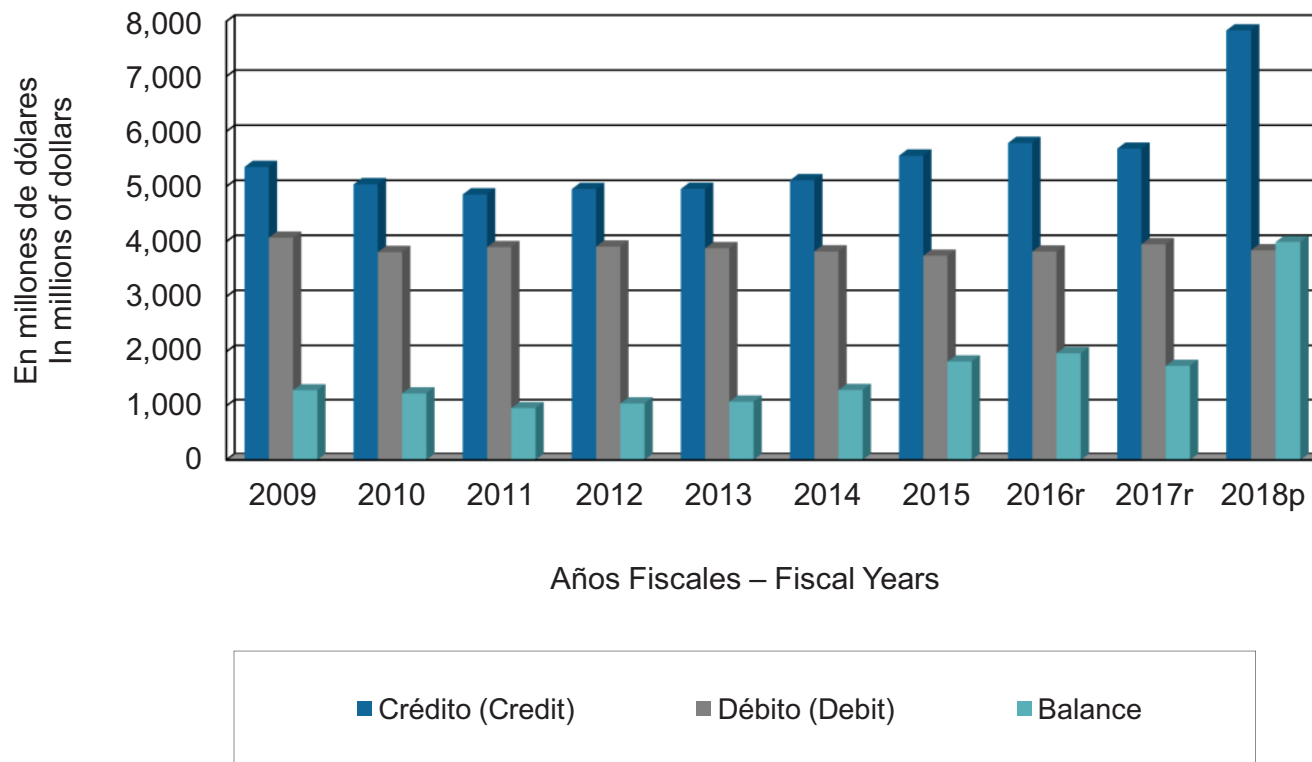

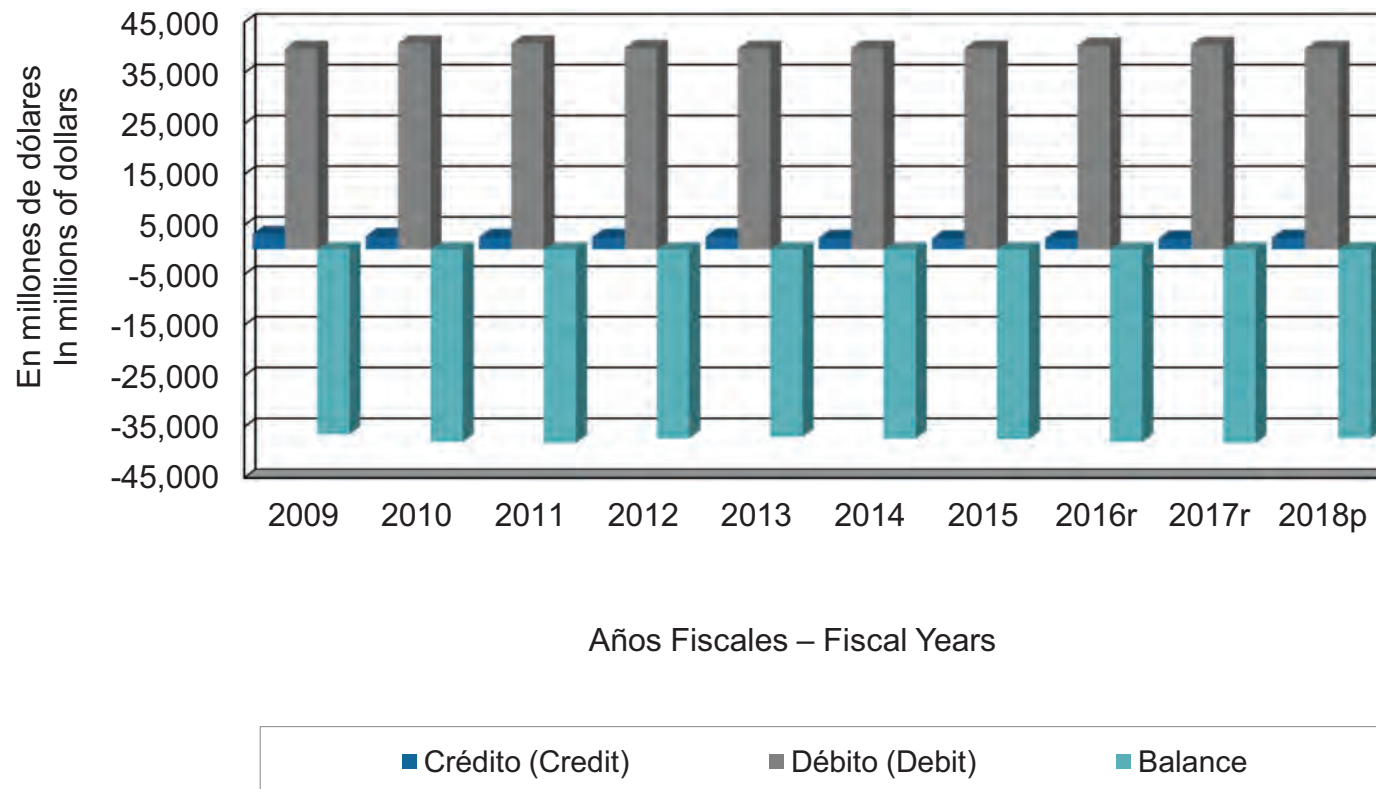
**GRAFICA 1 - BIENES**
