Pre-Posting Notice of Availability of Draft NPDES General Permit for Small Municipal Separate Storm Sewer Systems and Federal Facilities within the Commonwealth of Puerto Rico

Stormwater discharges associated with runoff from Municipal Separate Storm Sewer System within urbanized areas in Puerto Rico

The Environmental Protection Agency (EPA)-Region 2 is issuing this pre-posting notice of a Draft National Pollutant Discharge Elimination System (NPDES) general permit, PRR040000/ PRR04000F, for stormwater discharges from small municipal separate storm sewer systems (small MS4) from urbanized areas within the Commonwealth of Puerto Rico to waters of the United States. This draft NPDES general permit establishes Notice of Intent (NOI) requirements, standards, prohibitions and management practices for discharges of stormwater from small MS4's urbanized areas.

The draft permit describes two distinct small MS4s. These are the Conventional municipalities; and Non-Conventional State, Federal and other publicly owned systems; including transportation systems and State flood control pump station. The conditions in the final general permit are established pursuant to Clean Water Act (CWA) Part 402(p)(3)(iii) to ensure that pollutant discharges from small MS4s are reduced to the maximum extent practicable, protect water quality, and satisfy the appropriate water quality requirements of the CWA. The term small MS4 is available in 40 CFR Part 122.26(b). In addition, this term also includes systems similar to separate storm sewer systems and flood management conveyances in municipalities such as military bases, large hospital or prison complexes, highways, and flood control pump stations, and other thoroughfares.
