Resumen Ejecutivo

La publicación **Balanza de Pagos y Posición de Inversión Internacional de Puerto Rico 2023 (BPPII)** por parte de la Junta de Planificación, registra las transacciones entre los residentes de Puerto Rico y del exterior. En específico, la balanza de pagos es un estado estadístico que resume las transacciones entre residentes y no residentes durante un período. Comprende la cuenta de bienes y servicios, la cuenta del ingreso primario, la cuenta del ingreso secundario, la cuenta de capital y la cuenta financiera. Por su parte, la posición de inversión internacional es un estado estadístico que muestra el valor, en un momento dado, de los activos financieros de residentes de una economía que constituyen derechos sobre activos de no residentes, y los pasivos de los residentes de una economía frente a no residentes. Esta publicación presenta datos para los años fiscales 2014 a 2023.

El esfuerzo por modernizar el nivel de nuestras estadísticas de acuerdo con los modelos vigentes es uno continuo, con la intención que sea de acuerdo con los criterios metodológicos recomendados por los organismos pertinentes. Esto incluye la Organización de Naciones Unidas, el Fondo Monetario Internacional y el Negociado de Análisis Económico de los Estados Unidos. En lo que concierne a las transacciones entre Puerto Rico y el resto del mundo, la BPPII incorpora lo establecido en la sexta edición del Manual de Balanza de Pagos y Posición de Inversión Internacional (MBP6).

Nos reiteramos en la mejor disposición de mantener una verdadera retroalimentación con nuestros usuarios de información, para el beneficio de los grados de fidelidad y confianza de la información que se presente en nuestras publicaciones. Agradecemos a las entidades públicas y privadas que proveyeron los datos utilizados para preparar esta publicación.

Executive Summary

The publication **Balance of Payments and International Investment Position of Puerto Rico 2023 (BPIIP)** by the Puerto Rico Planning Board, records transactions between residents of Puerto Rico and abroad. Specifically, the Balance of Payments is a statistical statement that summarizes transactions between residents and nonresidents during a period. It consists of the goods and services account, the primary income account, the secondary income account, the capital account, and the financial account. For its part, the International Investment Position is a statistical statement that shows at a point in time the value of financial assets of residents of an economy that are claims on nonresidents, and the liabilities of residents of an economy to nonresidents. This publication presents data for fiscal years 2014 through 2023.

The effort to modernize the level of our statistics in accordance with current models is a continuous one, with the intention that it be in accordance with the methodological criteria recommended by the pertinent organisms. This includes the United Nations, the International Monetary Fund, and the United States Bureau of Economic Analysis. Regarding transactions between Puerto Rico and the rest of the world, the BPIIP incorporates the provisions of the sixth edition of the Balance of Payments and International Investment Position Manual (BPM6).

We reiterate our willingness to maintain a real feedback with our users of information, for the benefit of the fidelity and confidence levels of the information presented in our publications. We thank the public and private entities that provided the data used to prepare this publication.

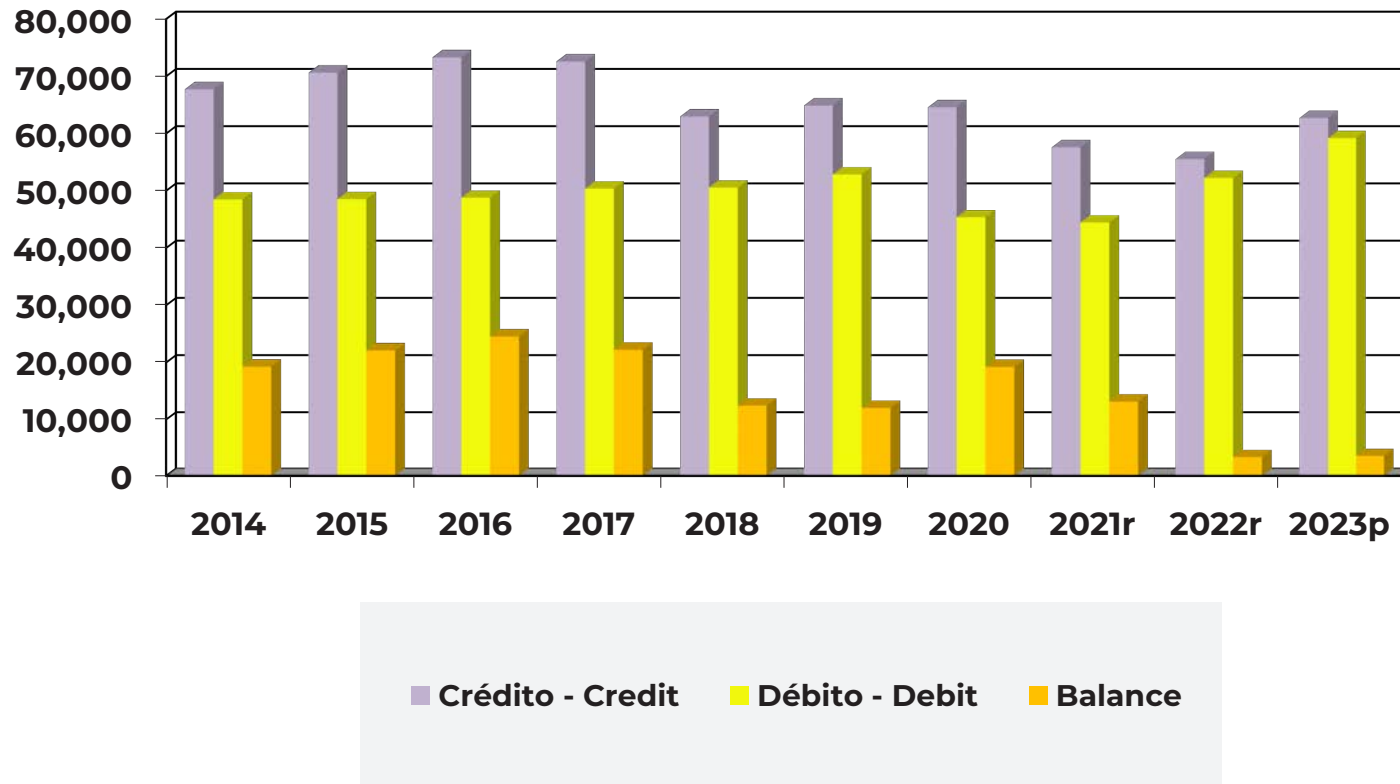

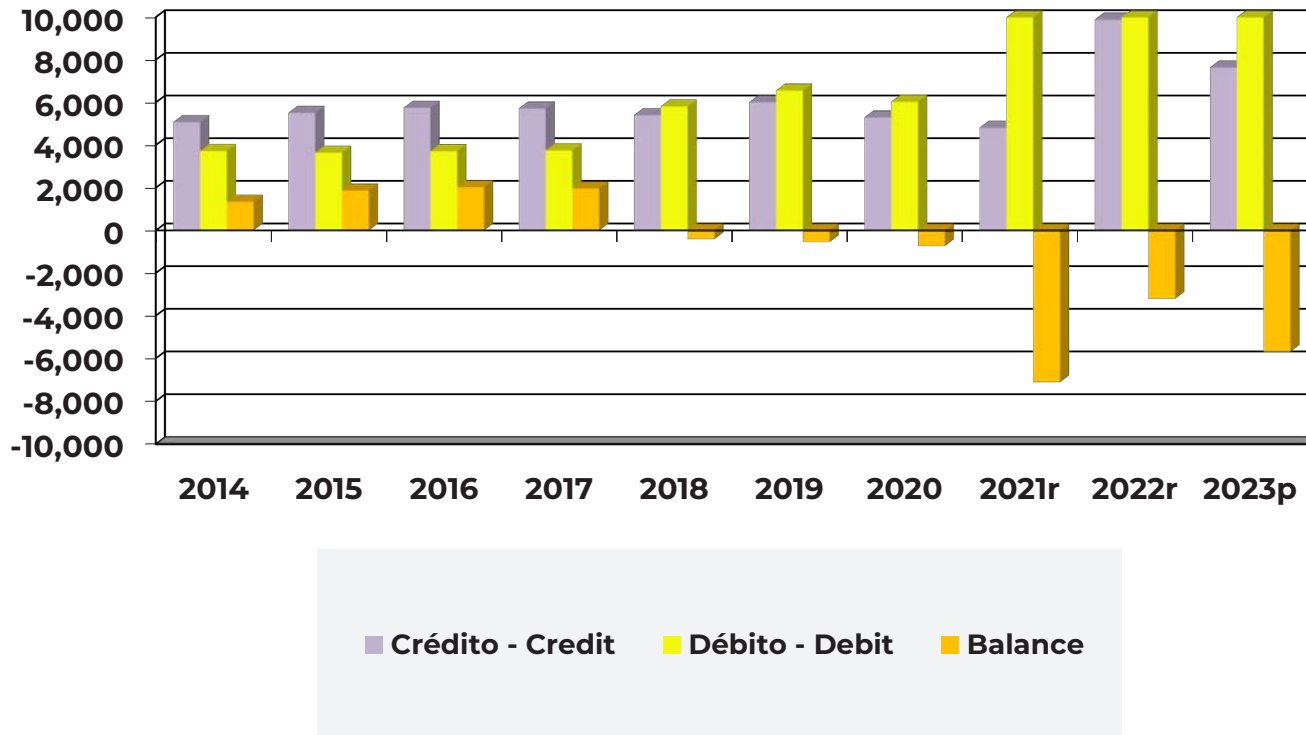

 (En millones de dólares - In millions of dollars)



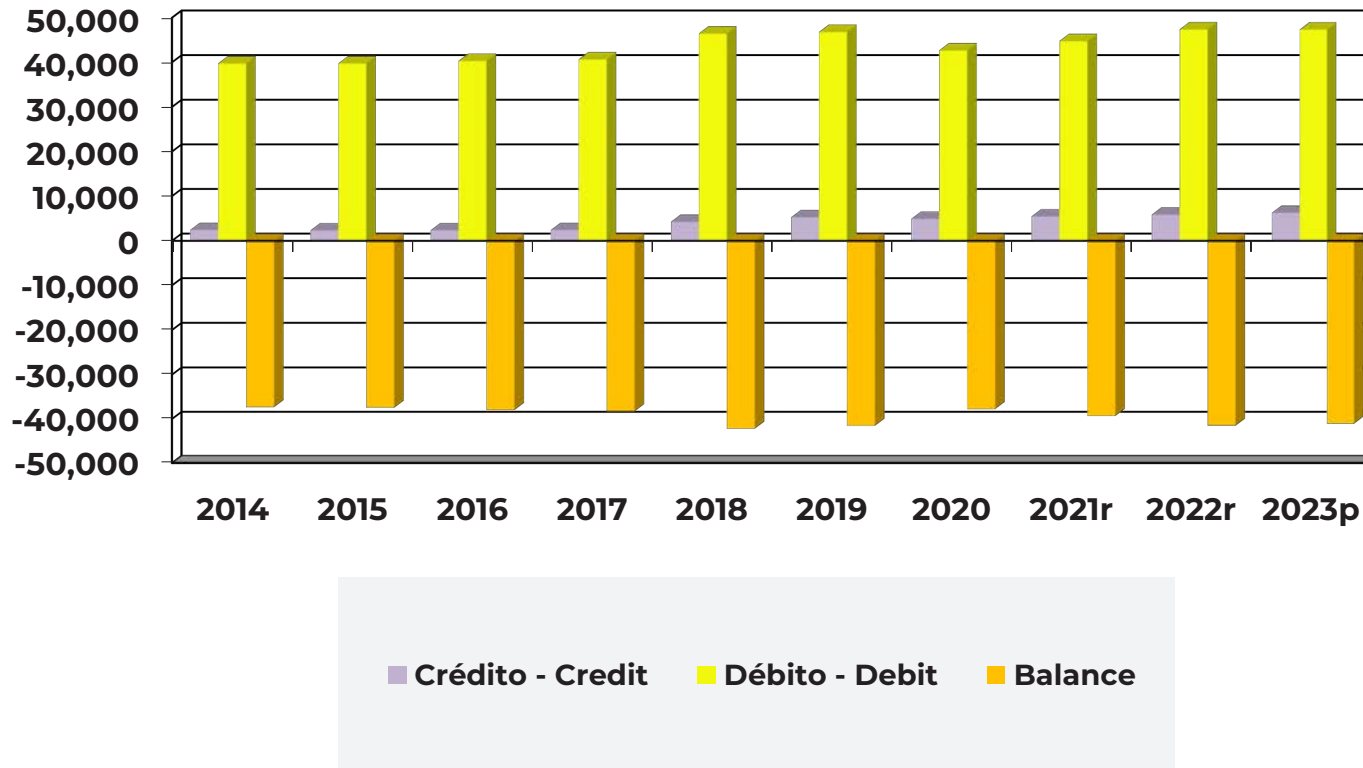

 (En millones de dólares - In millions of dollars)



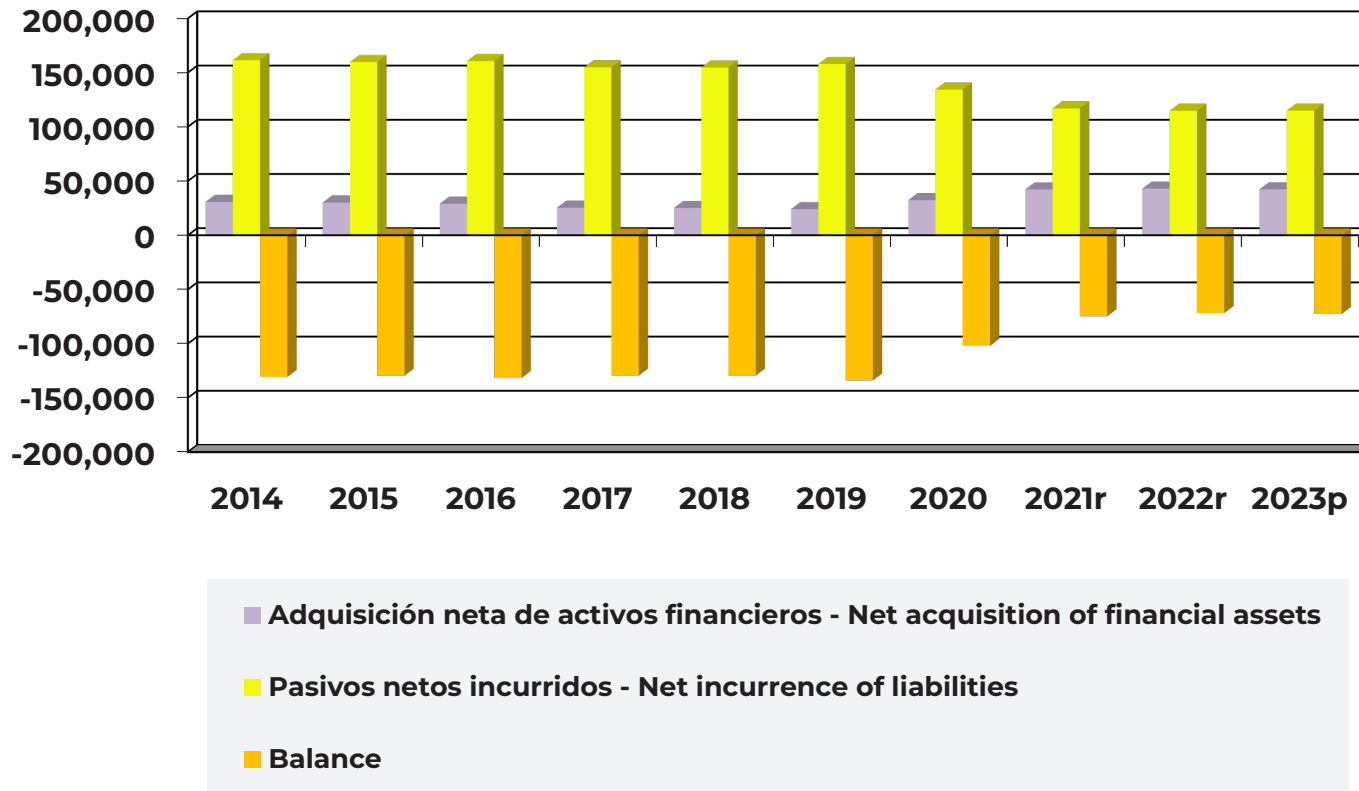
