PROPOSED AMENDMENT TO THE ZONING MAP OF THE
MUNICIPALITY OF ARECIBO

For the knowledge of the general public and in accordance with the provisions of Law Number 75 of June 24, 1975, known as the "Organic Law of the Planning Board of Puerto Rico"; Law Number 38 of June 30, 2017, known as the "Uniform Administrative Procedure Act of the Government of Puerto Rico"; and Law 107-2020, known as the Municipal Code of Puerto Rico," as amended, the Planning Board notifies that a virtual public hearing will be held to present the proposed amendment, petition number 2023-06-JPZ-0100 to the Zoning Map and/or Geodata of the Municipality of Arecibo.

ISSUES TO BE DISCUSSED:

Petition number 2023-06-JPZ-0100 proposes to amend the Zoning Map of the Municipality of Arecibo in the property identified with cadastre number 030-012-001-02 from District R-I to C-I, this property is located at PR-129 Road, Km. 1.6, Barrio Hato Abajo, of the Municipality of Arecibo.
