ISSUES TO BE DISCUSSED:

Petition number 2024-09-JPZ-0082 proposes to amend the Zoning Geodata of the Municipality of Vega Baja in the property identified with cadastre number 017-046-157-07 from District R-I to C-I, this property is located at 168 Casabe Road Int., Ave. Felisa Rincón de Gautier, Urb. San Demetrio, Barrio Puerto Nuevo, Municipality of Vega Baja.
